



### **Assumption of Risk and Waiver of Liability**

Relating to Coronavirus/COVID-19

Severe acute respiratory syndrome coronavirus 2 (“SARS-CoV-2”), which is responsible for Coronavirus Disease (collectively “COVID-19”), has been declared a worldwide pandemic by the World Health Organization. COVID-19 is highly contagious and is believed to spread mainly from person-to-person contact.

Consistent with San Mateo County Health directives currently allowing operations of youth camps, Hillsborough Little League (the “Organization”) offers a number of youth baseball programs. The Organization has put in place preventative measures intended to reduce the spread of COVID-19 and minimize the risk of infection to the same; however, the Organization does not and cannot guarantee that you, your child(ren), family, friends or others will not become exposed to, or infected with COVID-19 and/or any mutation or variation thereof while attending or participating in any Organization activities.

By registering for Organization activities, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), myself and others may be exposed to or infected by COVID-19 by participating in, or attending Organization sanctioned and coordinated activities, and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I further understand that the risk of becoming exposed to or infected by COVID-19 during Organization sanctioned or coordinated activities may result from the actions (negligent or not) of myself and others, including, but not limited to, the Organization, its Board, its contractors, its employees, its coaches and other volunteers, and its program participants and their families.

Additionally, by registering for Organization activities, I voluntarily agree to assume all of the previously mentioned risks and accept sole responsibility for any injury to my child(ren) or myself, illness, death, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s participation in Organization activities. On my behalf, and on behalf of my child(ren), I hereby release, pledge not to sue, and hold harmless the Organization, its Board, its contractors, its employees, its coaches and other volunteers, and its agents, of any and all claims, including all liabilities, actions, damages, costs or expenses of any kind arising out of or relating to exposure or contraction of COVID-19 and/or any mutation nor variation thereof. I understand and agree that this release includes any claims based on the actions (negligent or not) of the Organization, its Board, its contractors, its employees, its coaches and other volunteers, and its agents, regardless of whether a COVID-19 infection occurs before, during, or after participation in any Organization activity. I agree to abide by San Mateo County Health Directives and Organization guidelines on quarantining and returning to play, in the event of sickness or exposure. I acknowledge that the Organization reserves the right to suspend players found to be violating stated guidelines in order to protect the entirety of the Organization and its community.
